

A problem on semicubical powers

1. Introduction. Newton observed that an unordered set $\{h_1, \dots, h_N\}$ of real numbers is determined by the first N power sums: $h_1^K + \dots + h_N^K$, for $K = 1$ to N ([7]). If we are given that h_1, \dots, h_N are integers, then the set $\{h_1, \dots, h_N\}$ is often determined by a shorter sequence of power sums. This fact is important in I. M. Vinogradov's treatment of Waring's Problem. In their recent work on exponential sums ([1]) Bombieri and Iwaniec require a result of this type with $N = 4$, when the power sums with $K = 1$ and 2 are given and the power sum with $K = 3/2$ is given approximately. They require an upper bound for $I_8(H, \Delta)$, the number of integer solutions of the equations,

$$(1.1) \quad \sum_1^4 (h_j^2 - k_j^2) = \sum_1^4 (h_j - k_j) = 0,$$

$$(1.2) \quad \left| \sum_1^4 (h_j^{3/2} - k_j^{3/2}) \right| \leq \Delta H^{3/2},$$

$$(1.3) \quad H \leq h_j, k_j \leq 2H, \quad j = 1, \dots, 4,$$

where H is a positive integer and $0 \leq \Delta \leq 1$.

In the technical paper, [2], they obtain the bound $O(H^{4+\varepsilon})$ for any $\varepsilon > 0$, when $\Delta = 1/H$. They also obtain the same bound if the exponents in (1.2), which are all $3/2$, are replaced by any real number other than 0, 1 or 2. In this paper we show, by elementary means, that the number of integer solutions of (1.1), (1.2) and

$$(1.4) \quad 0 \leq h_j, k_j < H$$

is $\ll H^4 + \Delta H^5 \log^3 H$. We use Vinogradov's order of magnitude notation " $F \ll G$ " for $F = O(G)$. Replacing H by $2H$, we see that $I_8(H, \Delta) \ll H^4 + \Delta H^5 \log^3 H$.

If we impose the extra condition

$$(1.5) \quad \left| \sum_1^4 (h_j^{1/2} - k_j^{1/2}) \right| \leq \Delta_2 H^{1/2},$$

where Δ_2 can be chosen from $[\Delta, \Delta H \log H]$, then the number of solutions of (1.1), (1.2), (1.5) and (1.4) is $A(H) + O(\Delta H^5 \log^3 H)$, where

(1.6) $A(H) = 24H^4 - 72H^3 + 82H^2 - 33H$ is the number of "trivial solutions" of (1.1) and (1.4) for which (k_1, \dots, k_4) is a permutation of (h_1, \dots, h_4) .

Let $S = \sum_{H \leq h < 2H} \exp(2\pi i(\alpha h^2 + \beta h + \gamma(h/H)^{3/2}))$. By Lemma 2.3 of [1],

$$I_8(H, \Delta) \gg \Delta \int_{-1}^1 \int_{-1}^1 \int_{-1/\Delta}^{1/\Delta} |S|^8 d\alpha d\beta d\gamma \gg \Delta \int_{-1/96H^2}^{1/96H^2} \int_{-1/32H}^{1/32H} \int_{-1/64}^{1/64} |S|^8 d\alpha d\beta d\gamma$$

and expanding the product and integrating term by term gives $I_8(H, \Delta) \gg \Delta H^5$. A plausible conjecture would be that $\Delta H^5 \ll |I_8(H, \Delta) - A(H)| \ll \Delta H^5$, for $H^{-5} \ll \Delta \ll 1$. This conjecture is related to the Problem of Prouhet and Tarry, described in Section 21.9 of [4].

2. Linear families. If h_1, \dots, k_4 is a solution of (1.1), then so is $h_1 + t, \dots, k_4 + t$, for any real t . We call such a set of solutions a *family*. In this section we show that the integer solutions of (1.1) and (1.4) fall into $O(H^4)$ families.

LEMMA 1. For integers A, B the number of integer solutions of

$$x_1^2 + x_2^2 + x_3^2 = A,$$

$$x_1 + x_2 + x_3 = B$$

is

$$\omega(F) = \begin{cases} 1 & \text{if } F = 0, \\ 6 \sum_{d|F} \left(\frac{d}{3}\right) & \text{if } F/3 \text{ is a positive integer,} \\ 3 \sum_{d|F} \left(\frac{d}{3}\right) & \text{if } F \text{ is a positive integer and } (F, 3) = 1, \\ 0 & \text{in all other cases,} \end{cases}$$

where $\left(\frac{a}{b}\right)$ is Jacobi's symbol and $F = (3A - B^2)/2$.

Furthermore, if $F = 0$, then $x_1 = x_2 = x_3 = B/3$ and $B^2 = 3A$.

Proof. Writing $u = x_2 - x_1$, $v = x_3 - x_1$ we have

$$u^2 - uv + v^2 = x_1^2 + x_2^2 + x_3^2 - x_1 x_2 - x_2 x_3 - x_3 x_1 = (3A - B^2)/2 = F.$$

As $u^2 - uv + v^2$ is positive definite, solutions only exist if F is a non-negative integer. If $F = 0$, then $u = v = 0$ and $x_2 = x_1 = x_3$. If F is a positive integer, then, by a similar argument to Sections 16.9 and 16.10 of [4], there are

$6 \sum_{d|F} \left(\frac{d}{3}\right)$ integer solutions for (u, v) . Then $3x_1 = B - (u + v)$, $x_2 = u + x_1$, $x_3 = v + x_1$ and

$$(u + v)^2 = 3(u^2 + v^2) - 2(u^2 - uv + v^2) \equiv -2F \pmod{3} \equiv B^2 \pmod{3}.$$

If $3|F$, then $3|(u + v)$, $3|B$ and x_1 is an integer. If $(F, 3) = 1$, then $(B, 3) = (u + v, 3) = 1$, $u + v \equiv \pm B \pmod{3}$ and from each pair of solutions (u, v) , $(-u, -v)$ (which are distinct, as $u = v = 0$ implies $F = 0$) only one will correspond to an integral value for x_1 . This completes the proof of the lemma. ■

Let f be a family containing an integer solution of (1.4), h_1, \dots, k_4 . Suppose that h_4 is the least of h_1, \dots, k_4 . (There are 8 similar cases.) Let $x_i = h_i - h_4$, $y_i = k_i - h_4$, for $i = 1, \dots, 4$. We have, $0 \leq x_i \leq h_i < H$ and $0 \leq y_i \leq k_i < H$, for $i = 1, \dots, 4$, and $x_4 = 0$. As x_1, \dots, y_4 is a member of f it satisfies (1.1). Therefore, to count all such families as f at least once, it is sufficient to count the number of integer solutions of (1.1) and (1.4) of the form $x_1, x_2, x_3, 0, y_1, \dots, y_4$.

To apply Lemma 1 we fix y_1, \dots, y_4 and let $A = y_1^2 + \dots + y_4^2$, $B = y_1 + \dots + y_4$, so that

(2.1) $F = y_1^2 + \dots + y_4^2 - y_1 y_2 - y_2 y_3 - y_3 y_4 - y_4 y_1 - y_1 y_3 - y_2 y_4$ and $F = F(y)$ is an indefinite quadratic form in y_1, \dots, y_4 taking integer values at integer points.

If $\varepsilon > 0$, then $\omega(F) \leq \max\{1, 6d(F)\} \ll \max\{1, F^\varepsilon\} \ll H^\varepsilon$ and we see that there are $\ll H^\varepsilon$ solutions for x_1, x_2, x_3 . Now we let the y_i range over the integers in $[0, H)$ to count a total of $\ll H^{4+\varepsilon}$ families. We obtain a bound $\ll H^4$, by showing that $\omega(F)$ is $\ll 1$ on average.

When F is a positive integer, we write $F = F_1 F_3$, where F_3 is the largest power of 3 that divides F . Suppose that $\omega(F) \neq 0$, so by Lemma 1

$$0 \neq \sum_{d|F} \left(\frac{d}{3}\right) = \sum_{d|F_1} \left(\frac{d}{3}\right) = \prod_{p \parallel F_1} \left\{ \sum_{r=0}^{\beta} \left(\frac{p}{3}\right)^r \right\}$$

and

$$\sum_{r=0}^{\beta} \left(\frac{p}{3}\right)^r = \begin{cases} \beta + 1, & p \equiv 1 \pmod{3}, \\ (1 + (-1)^\beta)/2, & p \equiv -1 \pmod{3}, \end{cases}$$

where p is prime and the sign \parallel indicates that β is the highest power of p dividing F_1 . It follows that if $p^\beta \parallel F_1$, then either $p \equiv 1 \pmod{3}$ or β is even and so $p^\beta \equiv 1 \pmod{3}$ in both cases. This shows that $F_1 \equiv 1 \pmod{3}$. Now,

$$\sum_{d|F_1} \left(\frac{d}{3}\right) = \sum_{\substack{d|F_1 \\ d \leq \sqrt{F_1}}} \left(\frac{d}{3}\right) + \sum_{\substack{d|F_1 \\ d > \sqrt{F_1}}} \left(\frac{d}{3}\right).$$

Let $e = F_1/d$, then $d|F_1$, $d > \sqrt{F_1} \Leftrightarrow e|F_1$, $e < \sqrt{F_1}$ and $\left(\frac{d}{3}\right)\left(\frac{e}{3}\right) = \left(\frac{F_1}{3}\right)$,

so that $\left(\frac{d}{3}\right) = \left(\frac{e}{3}\right)$. By Lemma 1 it follows that

$$(2.2) \quad \omega(F) \leq 12 \sum'_{\substack{d|F_1 \\ d \leq \sqrt{F_1}}} \left(\frac{d}{3}\right),$$

where the \sum' indicates that weight $1/2$ is used when $d = \sqrt{F_1}$.

We now define two densities associated with the quadratic form $F(y_1, y_2, y_3, y_4)$ given by (2.1).

$$(2.3) \quad D(b \bmod q; y_1, y_2) = \frac{1}{q^2} \left\{ \sum_{\substack{y_3 \bmod q \\ F(y) \equiv b \pmod{q}}} \sum_{\substack{y_4 \bmod q \\ F(y) \equiv b \pmod{q}}} 1 \right\},$$

$$(2.4) \quad D(b \bmod q) = \frac{1}{q^4} \left\{ \sum_{\substack{y \bmod q \\ F(y) \equiv b \pmod{q}}} 1 \right\} = \frac{1}{q^2} \left\{ \sum_{\substack{y_1 \bmod q \\ F(y) \equiv b \pmod{q}}} \sum_{\substack{y_2 \bmod q \\ F(y) \equiv b \pmod{q}}} D(b \bmod q; y_1, y_2) \right\}.$$

These densities are multiplicative in q , by the Chinese Remainder Theorem, and will be evaluated using Gauss sums:

$$S(n, m) = \sum_{t \bmod m} e(nt^2/m), \quad \text{for } (n, m) = 1.$$

Here $e(x)$ denotes $\exp(2\pi i x)$, where $i = \sqrt{-1}$. The standard properties of Gauss sums are summarised as follows (see [5], Theorems 5.1 and 5.6 of Chapter 7).

LEMMA 2. If $(n, m) = c$, then

$$S(n, m) = cS(n/c, m/c).$$

If $(n, mm') = (m, m') = 1$, then

$$S(n, mm') = S(nm', m)S(nm, m').$$

If, further, m is odd and positive, then

$$S(n, m) = \left(\frac{n}{m}\right) \sqrt{\left(\frac{-1}{m}\right)} \sqrt{m}, \quad \text{where } \sqrt{-1} = i.$$

If, instead, m is a positive power of 2 and n is odd, then

$$S(n, m) = \begin{cases} 0, & \text{if } m = 2, \\ \left(\frac{m}{n}\right) \left(1 + \left(\frac{-1}{n}\right)i\right) \sqrt{m}, & \text{otherwise,} \end{cases}$$

and consequently, $S(n, 4m) = 2S(n, m)$ if $4|m$. ■

LEMMA 3. Let $c_q(a)$ denote Ramanujan's sum: $\sum_{n \bmod q}^* e(an/q)$, where the \sum^* indicates that the sum is taken over those n coprime to q .

If $(q, 3) = 1$, then

$$(2.5) \quad D(b \bmod q; v, w) = \frac{1}{q} \left\{ \sum_{r|q} \left(\frac{r}{3}\right) \frac{1}{r} c_r(3vw + b) \right\},$$

$$(2.6) \quad D(b \bmod q) = \frac{1}{q} \left\{ \sum_{r|q} \left(\frac{r}{3}\right) \frac{1}{r^2} c_r(b) \right\}.$$

If q is a positive power of 3, then

$$(2.7) \quad D(b \bmod q; v, w) = \frac{1}{q} \left\{ 1 + \sum_{1 < r|q} \left(\frac{3(3vw + b)/r}{3} \right) \right\},$$

$$(2.8) \quad D(b \bmod q) = \frac{1}{q} \left\{ 1 + \sum_{1 < r|q} \left(\frac{3b/r}{3} \right) \frac{3}{r} \right\},$$

where $\left(\frac{a}{d}\right) = 0$ unless a is an integer coprime to d .

Proof. From (2.1) we obtain

$$4F(v, w, x, y) = (x + y - 2v - 2w)^2 + 3(x - y)^2 - 12vw.$$

Let

$$(2.9) \quad h = x + y - 2v - 2w \quad \text{and} \quad k = x - y,$$

then

$$(2.10) \quad 4F(v, w, x, y) = h^2 + 3k^2 - 12vw.$$

From (2.3)

$$(2.11) \quad D(b \bmod q; v, w) = \frac{1}{q^2} \left\{ \sum_{x \bmod q} \sum_{y \bmod q} \frac{1}{q} \sum_{a \bmod q} e(a(F-b)/q) \right\} \\ = \frac{1}{q} \left\{ \sum_{r|q} \frac{1}{r^2} \sum_{A \bmod r}^* \sum_{x \bmod r} \sum_{y \bmod r} e(A(F-b)/r) \right\}$$

(here $\frac{A}{r} = \frac{a}{q}$). We now evaluate the sum over A in (2.11).

If q is odd, then so is r and we can rearrange the sum over A and use (2.9) and (2.10) to get

$$(2.12) \quad \sum_{A \bmod r}^* \sum_{x \bmod r} \sum_{y \bmod r} e\left(\frac{4A(F-b)}{r}\right) \\ = \sum_{A \bmod r}^* e\left(\frac{-4A(3vw+b)}{r}\right) \sum_{x \bmod r} \sum_{y \bmod r} e\left(\frac{A(h^2+3k^2)}{r}\right).$$

By (2.9) h and k are independent variables modulo r in the last double sum, which therefore equals

$$(2.13) \quad S(A, r) S(3A, r), \quad \text{for } (A, r) = 1.$$

If $(q, 3) = 1$, then, by Lemma 2, this is

$$(2.14) \quad \left(\frac{3}{r}\right) \sqrt{r} \left(\frac{-1}{r}\right) \sqrt{r} = \left(\frac{r}{3}\right) r.$$

As this is independent of A we may again rearrange the sum over A , (2.12), as

$$(2.15) \quad \left(\frac{r}{3}\right) r \sum_{A \bmod r}^* e(A(3vw+b)/r) = \left(\frac{r}{3}\right) r c_r(3vw+b).$$

If q is instead a positive power of 2, then we can rewrite the sum over A in (2.11) and use (2.9) and (2.10) to get

$$(2.16) \quad \sum_{A \bmod r}^* (1/4) \sum_{x \bmod 4r} (1/4) \sum_{y \bmod 4r} e(4A(F-b)/r) \\ = \sum_{A \bmod r}^* e(-A(3vw+b)/r) (1/16) \sum_{x \bmod 4r} \sum_{y \bmod 4r} e(A(h^2+3k^2)/4r).$$

By (2.9) we have $h \equiv k \pmod{2}$ and also $(x, y) \leftrightarrow (h, k)$ is a two-to-one correspondence modulo $4r$. The sum over x and y in (2.16) can therefore be split up in the following form

$$2 \sum_{\substack{h \bmod 4r \\ h \equiv k \pmod{2}}} \sum_{k \bmod 4r} \\ = 2 \left\{ \sum_{h \bmod 4r} \sum_{k \bmod 4r} - \sum_{\substack{h \bmod 4r \\ 2|h}} \sum_{k \bmod 4r} - \sum_{h \bmod 4r} \sum_{\substack{k \bmod 4r \\ 2|k}} + 2 \sum_{\substack{h \bmod 4r \\ 2|h}} \sum_{\substack{k \bmod 4r \\ 2|k}} \right\}.$$

The result is

$$(2.17) \quad 2(S(A, 4r) S(3A, 4r) - 2S(A, r) S(3A, 4r) \\ - 2S(A, 4r) S(3A, r) + 8S(A, r) S(3A, r)).$$

If $4|r$, then, by Lemma 2, this is

$$(2.18) \quad 2(4 - 4 - 4 + 8) S(A, r) S(3A, r) = 8S(A, r) S(3A, r) \\ = 8 \left(\frac{r}{A}\right) \left(1 + \left(\frac{-1}{A}\right)i\right) \sqrt{r} \left(\frac{r}{3A}\right) \left(1 + \left(\frac{-1}{3A}\right)i\right) \sqrt{r} \\ = 8 \left(\frac{r}{3}\right) \left|1 + \left(\frac{-1}{A}\right)i\right|^2 r = 16r \left(\frac{r}{3}\right).$$

If $r = 2$, then, by Lemma 2, (2.17) is

$$2S(A, 8) S(3A, 8) = 2 \left(\frac{8}{A}\right) \left(1 + \left(\frac{-1}{A}\right)i\right) \sqrt{8} \left(\frac{8}{3A}\right) \left(1 + \left(\frac{-1}{3A}\right)i\right) \sqrt{8} \\ = 16 \left(\frac{8}{3}\right) \left|1 + \left(\frac{-1}{A}\right)i\right|^2 = 16 \left(\frac{2}{3}\right) 2,$$

which is just (2.18). Hence, using (2.18) in (2.16) and replacing A by $-A$, we again see that the sum over A , (2.12), is given by (2.15).

If q is odd and coprime to 3, or if q is a positive power of 2, then from (2.15) and (2.11) we obtain (2.5). As the densities are multiplicative in q , we obtain (2.5) for any q coprime to 3. Then, by (2.4) and (2.5), we obtain

$$D(b \bmod q) = \frac{1}{q^3} \left\{ \sum_{r|q} \left(\frac{r}{3}\right) \frac{1}{r} \sum_{A \bmod r}^* \sum_{v \bmod q} \sum_{w \bmod q} e((3vw+b)A/r) \right\} \\ = \frac{1}{q} \left\{ \sum_{r|q} \left(\frac{r}{3}\right) \frac{1}{r^3} \sum_{A \bmod r}^* e(bA/r) \sum_{v \bmod r} \sum_{w \bmod r} e(3vwA/r) \right\},$$

if $(q, 3) = 1$.

In the above sum r will be coprime to $3A$, so that the sum over w equals zero, unless $r|v$, when it equals r . (2.6) follows, for any q coprime to 3.

Let q be a positive power of 3.

$$(2.19) \quad \text{When } r = 1, \text{ the sum over } A \text{ in (2.11) is just 1.}$$

If $r > 1$, then the sum over A in (2.11) is given by (2.12) and, instead of (2.14), we get, by (2.13) and Lemma 2,

$$\begin{aligned} S(A, r) 3S(A, r/3) &= 3 \left(\frac{A}{r} \right) \sqrt{\left(\frac{-1}{r} \right)} \sqrt{r} \left(\frac{A}{r/3} \right) \sqrt{\left(\frac{-1}{r/3} \right)} \sqrt{r/3} \quad ((A, r) = 1) \\ &= \sqrt{3} \left(\frac{A}{3} \right) \sqrt{\left(\frac{-1}{3} \right)} r = i \sqrt{3} \left(\frac{A}{3} \right) r. \end{aligned}$$

The sum over A , (2.12), is then

$$i \sqrt{3} r \sum_{A \bmod r}^* \left(\frac{A}{3} \right) e(-4A(3vw+b)/r)$$

and rearranging this gives

$$(2.20) \quad -i \sqrt{3} r \sum_{A \bmod r}^* \left(\frac{A}{3} \right) e(A(3vw+b)/r).$$

Summing over $B = A+3$ shows that, if r does not divide $3(3vw+b)$, then (2.20) is zero. If $r \mid 3vw+b$, then summing over $B = -A$ shows that (2.20) is zero. The remaining case is when $r/3$ is the highest power of 3 dividing $3vw+b$. (2.20) then becomes

$$\begin{aligned} -i \sqrt{3} r \frac{r}{3} \sum_{A \bmod 3}^* \left(\frac{A}{3} \right) e((A(3vw+b)/(r/3))/3) \\ = -i(r^2/\sqrt{3}) \left(\frac{(3vw+b)/(r/3)}{3} \right) \sum_{B \bmod 3}^* \left(\frac{B}{3} \right) e(B/3). \end{aligned}$$

The sum over B is $2i \sin 2\pi/3 = i \sqrt{3}$, so that (2.20) is

$$(2.21) \quad \left(\frac{(3vw+b)/(r/3)}{3} \right) r^2 = \left(\frac{3(3vw+b)/r}{3} \right) r^2.$$

With the convention that $\left(\frac{a}{d} \right) = 0$, unless a is an integer coprime to d , we see that (2.21) is also true in the cases where $r/3$ was not the highest power of 3 to divide $3vw+b$. From (2.19), (2.21) and (2.11) we obtain (2.7).

By (2.4) we may obtain $D(b \bmod q)$ by summing $D(b \bmod q; v, w)$ over v and w modulo q , then dividing by q^2 . We may carry this out on (2.20), to obtain, for $r > 1$

$$\frac{1}{q^2} (-i \sqrt{3} r) \sum_{A \bmod r}^* \left(\frac{A}{3} \right) e(Ab/r) (q/(r/3))^2 \sum_{v \bmod (r/3)} \sum_{w \bmod (r/3)} e(Avw/(r/3)).$$

Here $(A, 3) = 1$, so that the sum over w equals zero, unless $v \equiv 0 \pmod{r/3}$,

when it equals $r/3$. We obtain

$$(2.22) \quad -i3 \sqrt{3} \sum_{A \bmod r}^* \left(\frac{A}{3} \right) e(Ab/r).$$

The sum over A here is of the same form as that occurring in (2.20), so that we may treat (2.22) in the same way to get

$$(2.23) \quad \frac{3}{r} \left(\frac{3b/r}{3} \right) r^2 = 3 \left(\frac{3b/r}{3} \right) r.$$

By (2.19) the contribution from $r = 1$ is

$$(2.24) \quad \frac{1}{q^2} \left\{ \sum_{v \bmod w} \sum_{w \bmod q} 1 \right\} = 1.$$

Summing the results from (2.23) and (2.24) over $r \mid q$, with weight $q/(r^2)$, we obtain (2.8) and the proof of the lemma is complete. ■

By short-circuiting the proof in [3], we obtain the following less refined result.

LEMMA 4. Let \mathcal{A} be a measurable subset of $\prod_{i=1}^n [A_i, A_i + I_i]$, with the property, that every line in \mathbb{R}^n which is parallel to one of the coordinate axes intersects \mathcal{A} on a set consisting of at most c disjoint connected components in the line. Then

$$\left| \sum_{\mathbb{Z}^n} \chi_{\mathcal{A}}(x) - \int_{\mathbb{R}^n} \chi_{\mathcal{A}}(x) dx \right| \leq c \left\{ \prod_{i=1}^n (I_i + 1) - \prod_{i=1}^n I_i \right\},$$

where $\chi_{\mathcal{A}}(x)$ is the characteristic function of \mathcal{A} . ■

LEMMA 5. Let q be a positive integer, $F(X_1, \dots, X_n)$ a non-constant polynomial with the degree in each variable being $\leq d$. Let

$$\mathcal{A} = \{x \in \mathbb{R}^n; F(x) \geq b; 0 \leq x_i \leq I, i = 1, \dots, n\}$$

and let $V(\mathcal{A})$ denote the volume of \mathcal{A} . If $w(x)$ is any weight function on \mathcal{A} with $0 \leq w(x) \leq 1$ and $w(x) = 1$ if $F(x) > b$, then, for any $a \in \mathbb{R}^n$,

$$\left| \left\{ \sum_{\substack{x \in \mathcal{A} \\ x \equiv a \pmod{q}}} w(x) \right\} - \frac{1}{q^n} V(\mathcal{A}) \right| \leq [(d+2)/2] \left\{ \sum_{r=0}^{n-1} \binom{n}{r} (I/q)^r \right\},$$

where $[u]$ denotes the integer part of u .

Proof. Let $\mathcal{D} = \{x \in \mathcal{A}; F(x) > b\}$. \mathcal{D} is a finite intersection of measurable sets and is therefore a measurable set. Now

$$\sum_{\substack{x \in \mathcal{A} \\ x \equiv a \pmod{q}}} 1 = \sum_{y \in \mathbb{Z}^n} \chi_{\mathcal{A}}(y),$$

where $\mathcal{A} = \frac{1}{q}(\mathcal{D} - a)$. \mathcal{A} is a measurable subset of $\times_{i=1}^n [-a_i/q, -a_i/q + I/q]$. To show that \mathcal{A} satisfies the conditions of Lemma 4, let $1 \leq j \leq n$, let

$$y_i = b_i, \quad \text{for } i = 1, \dots, n, i \neq j$$

be the equation of a line parallel to the j -axis and let z be a point on that line. z is a point in \mathcal{A} if and only if $-a_j/q \leq z_j \leq -a_j/q + I/q$ and $F(qz + a) > b$.

$F(qz + a) - b = g(z_j)$, a polynomial in z_j of degree at most d .

$\mathcal{S} = \{z_j; z \in \mathcal{A}\}$ is the intersection of an open subset of \mathbf{R} with $[-a_j/q, -a_j/q + I/q]$. The boundary points of \mathcal{S} in \mathbf{R} are either roots of g , or $-a_j/q$, or $-a_j/q + I/q$. Every disjoint connected component of \mathcal{S} has two boundary points in \mathbf{R} . Each boundary point bounds at most two disjoint connected components of \mathcal{S} . Two disjoint connected components of \mathcal{S} share the same boundary point only when that point is a multiple root of g . As g has at most d roots (counting multiplicity), it follows that \mathcal{S} has at most $[(d+2)/2]$ disjoint connected components.

\mathcal{A} satisfies the conditions of Lemma 4 and we obtain

$$\left| \sum_{z \in \mathcal{A}} \chi_{\mathcal{A}}(y) - \int_{\mathbf{R}^n} \chi_{\mathcal{A}}(y) dy \right| \leq [(d+2)/2] \left(\left((I/q) + 1 \right)^n - (I/q)^n \right).$$

Putting this in terms of x , we obtain

$$\left| \left\{ \sum_{\substack{x \in \mathcal{D} \\ x \equiv a \pmod{q}}} 1 \right\} - \frac{1}{q^n} V(\mathcal{D}) \right| \leq [(d+2)/2] \left\{ \sum_{r=1}^{n-1} \binom{n}{r} (I/q)^r \right\}.$$

By a similar argument, with minor adjustments, we obtain the above result, with \mathcal{D} replaced by \mathcal{A} . Now $\mathcal{A} - \mathcal{D}$ has measure zero, so $V(\mathcal{A}) = V(\mathcal{D})$ and

$$\left\{ \sum_{\substack{x \in \mathcal{D} \\ x \equiv a \pmod{q}}} 1 \right\} \leq \left\{ \sum_{\substack{x \in \mathcal{A} \\ x \equiv a \pmod{q}}} w(x) \right\} \leq \left\{ \sum_{\substack{x \in \mathcal{A} \\ x \equiv a \pmod{q}}} 1 \right\}$$

so that we may combine the results for \mathcal{A} and \mathcal{D} to complete the proof of the lemma. ■

LEMMA 6. The integer solutions of (1.1) and (1.4) fall into $O(H^4)$ families.

Proof. After the discussion following Lemma 1, we may use Lemma 1 and (2.2) to see that the number of such families is

$$\leq \left\{ \sum_{F(y)=0} 1 \right\} + \sum_{\substack{F(y) > 0 \\ F_1 \equiv 1 \pmod{3}}} \left\{ \frac{1}{2} + \sum_{d < \sqrt{F_1}} \left(\frac{d}{3} \right) \right\},$$

where \sum_y denotes the sum over the integers y_1, \dots, y_4 in $[0, H)$. In this region $F(y) < H^2$. The above expression is at most

$$(2.25) \quad \left\{ \sum_y 1 \right\} + \sum_m \sum_{1 \leq d < H/(\sqrt{3})^m} \left(\frac{d}{3} \right) \sum_{\substack{y \in \mathcal{A} \\ F(y) \equiv b \pmod{q}}} 1, \\ \text{where } F_3 = 3^m, q = 3^{m+1}d, b \text{ is the least positive integer satisfying} \\ \text{the congruences } b \equiv 3^m \pmod{3^{m+1}} \text{ and } b \equiv 0 \pmod{d} \text{ and} \\ \mathcal{A} = \{x \in \mathbf{R}^4; F(x) > 3^m d^2; 0 \leq x_i \leq H-1, i = 1, \dots, 4\}.$$

The first sum over y is H^4 . The last sum over y is

$$\sum_{\substack{a \pmod{q} \\ F(a) \equiv b \pmod{q}}} \sum_{\substack{y \in \mathcal{A} \\ y \equiv a \pmod{q}}} 1.$$

\mathcal{A} satisfies the conditions of Lemma 5, with $n = 4$, $d = 2$, so that the inner sum here is

$$\frac{1}{q^4} V(\mathcal{A}) + O((H/q)^3 + 1).$$

If $q \leq 3H$, then we sum over a to see, that

$$\sum_{\substack{y \in \mathcal{A} \\ F(y) \equiv b \pmod{q}}} 1 = (V(\mathcal{A}) + O(qH^3)) D(b \pmod{q}).$$

If $q > 3H$, then, as $d < H/(\sqrt{3})^m \leq H$, there is a unique integer t with

$$(2.26) \quad 1 \leq t \leq m \quad \text{and} \quad H < q_1 \leq 3H, \quad \text{where } q_1 = 3^t d.$$

Arguing as above and using (2.25) and (2.26), we obtain

$$\sum_{\substack{y \in \mathcal{A} \\ F(y) \equiv b \pmod{q}}} 1 \leq \sum_{\substack{y \in \mathcal{A} \\ F(y) \equiv 0 \pmod{q_1}}} 1 = (V(\mathcal{A}) + O(q_1 H^3)) D(0 \pmod{q_1}) \\ \ll H^4 D(0 \pmod{q_1}).$$

It now remains to estimate three sums.

First Sum:

$$S_1 = \sum_m \sum_{1 \leq d < H/3^m} \left(\frac{d}{3} \right) V(\mathcal{A}) D(b \pmod{q}).$$

By the multiplicativity of the densities and Lemma 3,

$$S_1 = \sum_m \frac{1}{3^{m+1}} \left(1 + \frac{1}{3^m} \right) \sum_{1 \leq d < H/3^m} \left(\frac{d}{3} \right) V(\mathcal{A}) \frac{1}{d} \sum_{r|d} \left(\frac{r}{3} \right) \frac{1}{r^2} \varphi(r).$$

Let $d = re$ and use $\varphi(r) \leq r$, to see that

$$S_1 \ll \sum_m \frac{1}{3^m} \sum_r \frac{1}{r^2} \left| \sum_{1 \leq e < H/3^m r} \left(\frac{e}{3} \right) \frac{V(\mathcal{A})}{e} \right|.$$

For fixed m and r , $V(\mathcal{A})$ is non-increasing, as e increases, so that the innermost sum is bounded below, by zero, and above, by its first term ($e = 1$), which is at most H^4 . The sums over m and r converge and $S_1 \ll H^4$.

Second Sum:

$$S_2 = \sum_m \sum_{\substack{1 \leq d < H/3^m \\ (d,3)=1}} qH^3 D(b \bmod q).$$

We proceed as above, with $d = re$, and also use $\left| \left(\frac{r}{3} \right) \right| \leq 1$ to show that

$$S_2 \ll H^3 \sum_m \sum_r \frac{1}{r} \sum_{1 \leq e < H/3^m r} 1 \ll H^4,$$

since the sum over e is $\ll H/3^m r$.

Third Sum:

$$S_3 = \sum_m \sum_{\substack{H/3^m < d < H/(\sqrt{3})^m \\ (d,3)=1}} H^4 D(0 \bmod q_1).$$

As the densities are non-negative, we may use (2.26) to replace one H with $3^i d$. Then, as above, we let $d = re$ to obtain the bound

$$S_3 \ll H^3 \sum_m \sum_r \frac{1}{r} \sum_{e < H/(\sqrt{3})^m r} 1 \ll H^4,$$

since the sum over e is $\ll H/(\sqrt{3})^m r$.

This completes the proof of the lemma. ■

3. Using the inequality. Given a solution of (1.1), h_1, \dots, h_4 , in a family, f , we define the polynomials

$$P(x) = (x - h_1) \dots (x - h_4), \quad Q(x) = (x - k_1) \dots (x - k_4)$$

and the products $P_i(f) = P(k_i)$, $Q_i(f) = Q(h_i)$, for $i = 1, \dots, 4$. These products are determined by f .

(3.1) We say that the family is "trivial" if and only if

$$P_i(f) = Q_i(f) = 0, \quad \text{for } i = 1, \dots, 4.$$

LEMMA 7. A solution of (1.1) is trivial (in the sense of (1.6)) if and only if it is a member of a trivial family (in the sense of (3.1)). The number of trivial

solutions of (1.1) and (1.4) in integers is

$$(3.2) \quad A(H) = 24H^4 - 72H^3 + 82H^2 - 33H.$$

Proof. If a solution of (1.1) is a trivial member of a family, f , then $P(x) = Q(x)$. Therefore $P_i(f) = P(k_i) = Q(k_i) = 0$, for $i = 1, \dots, 4$ and similarly for the $Q_i(f)$. By (3.1), f is trivial.

If a solution of (1.1) is a member of a trivial family, f , then

$$0 = P_i(f) = P(k_i) \Rightarrow k_i \in \{h_1, \dots, h_4\}, \quad \text{for } i = 1, \dots, 4.$$

By symmetry, $\{h_1, \dots, h_4\} = \{k_1, \dots, k_4\}$, as unordered sets. There are now four cases to consider.

Case 1: h_1, \dots, h_4 take 4 distinct values. k_1, \dots, k_4 are a permutation of these values, so the solution is trivial. There are $4! H! / (H-4)!$ such integer solutions of (1.1) and (1.4).

Case 2: h_1, \dots, h_4 take 3 distinct values, A, B, C . The linear equation in (1.1) is of one of the forms $2A + B + C = A + 2B + C$ or $2A + B + C = 2A + B + C$. From the former equation we find $A = B$, a contradiction. From the latter equation it is seen that the solution is trivial and there are $\binom{4}{2} \frac{4! H!}{2! (H-3)!}$

such integral solutions of (1.1) and (1.4).

Case 3: h_1, \dots, h_4 take 2 distinct values, A, B . The linear equation in (1.1) takes the form $nA + (4-n)B = mA + (4-m)B$, $n \in \{1, 2\}$. Whence $(m-n)A = (m-n)B \Rightarrow m = n$ and the solution is trivial. For $n = 1, 2$ there are, respectively,

$$\binom{4}{3} \frac{4! H!}{3! (H-2)!}, \quad \frac{1}{2} \binom{4}{2} \frac{4! H!}{2! 2! (H-2)!}$$

such integral solutions of (1.1) and (1.4).

Case 4: If h_1, \dots, h_4 all take the same value, A , then so do k_1, \dots, k_4 . The solution is trivial and there are H such integral solutions of (1.1) and (1.4). This completes the proof of the lemma. ■

LEMMA 8. If $\delta, K > 0$ and $|x_j|, |y_j| \leq K$ for $j = 1, \dots, N$ and

$$\sum_1^N (x_j^\beta - y_j^\beta) \ll \delta K^\beta, \quad \text{for } \beta = 1, \dots, N,$$

then

$$\prod_1^N (x_j^r - y_j^r) \ll \delta K^{Nr}, \quad \text{for } i = 1, \dots, N, \quad 1 \leq r \in \mathbb{Z}.$$

The implied constant depends on r, N and the implied constant in the hypothesis.

Proof. For $0 \leq \beta \leq N$ we define the polynomials

$$S_\beta = S_\beta(X) = S_\beta(X_1, \dots, X_N) = \sum_1^N X_j^\beta$$

and the polynomials $E_\beta = E_\beta(X) = E_\beta(X_1, \dots, X_N)$

$$\prod_1^N (\lambda - X_j) = \sum_0^N E_{N-j} \lambda^j.$$

We then have

$$(3.3) \quad \left| \prod_{j=1}^N (x_j - y_j) \right| = \left| \prod_{j=1}^N (y_i - x_j) - \prod_{j=1}^N (y_i - y_j) \right| = \left| \sum_{j=0}^N (E_{N-j}(x) - E_{N-j}(y)) y_i^j \right|$$

$$\leq \sum_{j=0}^{N-1} |E_{N-j}(x) - E_{N-j}(y)| K^j.$$

Now $E_1(x) - E_1(y) = S_1(x) - S_1(y) \leq \delta K$, which proves the lemma in the case $r = N = 1$. For $N > 1$, we may take, as an induction hypothesis,

$$(3.4) \quad |E_r(x) - E_r(y)| \leq 3N^{r-1} \delta K^r \quad \text{for } 1 \leq r < m \leq N.$$

From [7], p. 166, we have the equation, true for $1 \leq m \leq N$,

$$S_m + E_1 S_{m-1} + \dots + E_{m-1} S_1 + E_m m = 0.$$

We find

$$|E_m(x) - E_m(y)| \leq \frac{1}{m} \sum_{r=0}^{m-1} |E_r(x) S_{m-r}(x) - E_r(y) S_{m-r}(y)|$$

$$\leq \frac{1}{m} \sum_{r=0}^{m-1} (|E_r(x) - E_r(y)| |S_{m-r}(x)| + |E_r(y)| |S_{m-r}(x) - S_{m-r}(y)|)$$

and, by the hypotheses of the lemma and the induction hypothesis, (3.4), this is

$$\leq \frac{1}{m} \sum_{r=0}^{m-1} \left(3N^{r-1} \delta K^r N K^{m-r} + \binom{N}{r} K^r \delta K^{m-r} \right)$$

$$\leq \delta K^m \sum_{r=0}^{m-1} \left(3N^r + \binom{N}{r} \right) / m$$

$$\leq \delta K^m \sum_{r=0}^{m-1} 4N^r / m \leq \delta K^m N^{m-1} (4(1 - N^{-m})) / (m(1 - N^{-1}))$$

$$\leq \delta K^m N^{m-1} (4(1 - N^{-2})) / (2(1 - N^{-1})),$$

since $1 < m \leq N$. Therefore, for $N \geq 2$, we get

$$|E_m(x) - E_m(y)| \leq \delta K^m N^{m-1} (2(1 + N^{-1})) \leq 3N^{m-1} \delta K^m$$

and the induction hypothesis, (3.4), is true with $m = N$.

By (3.3) and (3.4), with $m = N$,

$$\left| \prod_{j=1}^{N-1} (x_j - y_j) \right| \leq \sum_{j=0}^{N-1} 3N^{N-j-1} \delta K^{N-j} K^j \leq 3\delta K^N N^{N-1} (1 - N^{-1}) \leq 6N^{N-1} \delta K^N,$$

for $N \geq 2$. This proves the lemma in the case $r = 1$. From the above result we deduce

$$\left| \prod_{j=1}^N (x_j^r - y_j^r) \right| = \left| \prod_{j=1}^N (x_j - y_j) (x_j^{r-1} + x_j^{r-2} y_j + \dots + y_j^{r-1}) \right|$$

$$\leq (rK^{r-1})^N \left| \prod_{j=1}^N (x_j - y_j) \right| \leq 6r^N N^{N-1} \delta K^r,$$

which completes the proof of the lemma. ■

Our next lemma carries the burden of the proof. First we introduce some notation:

Given a family, f , and a member of f , (h_1, \dots, k_4) , we can parametrise the family as $f = \{(h_1 + t, \dots, k_4 + t); t \in \mathbb{R}\}$. Then we can define the real function of t ,

$$(3.5) \quad M_\beta(f, t) = \sum_1^4 ((h_i + t)^\beta - (k_i + t)^\beta),$$

where

$$\beta > 0 \quad \text{and} \quad t \geq -\min\{h_1, \dots, k_4\}.$$

The graph of $M_\beta(f, t)$ is determined by β and f , up to a translation parallel to the t -axis.

LEMMA 9. The number of non-trivial families, f , which contain a solution of (1.4) in integers, (h_1, \dots, k_4) , and for which there is a value of t satisfying

$$(3.6) \quad 0 \leq h_i + t, k_i + t \leq H, \quad \text{for } i = 1, \dots, 4$$

and

$$(3.7) \quad |M_{3/2}(f, t)| \leq \delta H^{3/2}, \quad |M_{1/2}(f, t)| \leq \delta H^{1/2}$$

is $\leq \delta H^4 \log^2 H$.

Proof. We first dispose of those f for which some $P_i(f)$ or $Q_i(f)$ is zero. In this case some h_i equals some k_j . There are 16 possible similar cases. We assume that $h_4 = k_4$. h_4 and k_4 eliminate each other from the equations (1.1) and (3.7). An appeal to Lemma 8, with $N = 3$, $x_i = \sqrt{h_i + t}$, $y_i = \sqrt{k_j + t}$, $K = \sqrt{H}$ (by (3.6)), δ the same as in (3.7) and $r = 2$, shows that

$$(3.8) \quad (h_1 - k_3)(h_2 - k_3)(h_3 - k_3) \leq \delta H^3.$$

If this product were zero, then some h_i equals k_3 , for $i \leq 3$. There are 3 possible similar cases. We assume that $h_3 = k_3$. Equations (1.1) reduce to

$h_1^2 + h_2^2 = k_1^2 + k_2^2$ and $h_1 + h_2 = k_1 + k_2$. Whence (k_1, k_2) is a permutation of (h_1, h_2) and (h_1, \dots, k_4) is a trivial solution of (1.1). As f is non-trivial, Lemma 7 shows that it contains no trivial solutions of (1.1). Therefore, the above product, (3.8), cannot be zero. f contains a member (u_1, \dots, v_4) , where $u_i = h_i - k_3$, $v_i = k_i - k_3$, $-H \leq u_i$, $v_i \leq H$ (by (1.4)), for $i = 1, \dots, 4$, $v_3 = 0$, $v_4 = u_4$ (as $k_4 = h_4$), $0 \neq u_1 u_2 u_3 \ll \delta H^3$ (by (3.8)) and v_1, v_2 are the roots of a quadratic polynomial with coefficients which are functions of u_1, u_2, u_3 only.

There are

$$\begin{aligned} &\ll H \text{ choices for } v_4 = u_4, \\ &\ll \delta H^3 \log^2 H \text{ choices for } u_1, u_2, u_3 \end{aligned}$$

and then

$$\ll 1 \text{ choices for } v_1, v_2.$$

Taking account of all 16 similar cases, we see that

(3.9) there are $\ll \delta H^4 \log^2 H$ families, f , which satisfy the conditions of the lemma and have some $P_i(f)$ or $Q_i(f)$ equal to zero.

We now count those f with no $P_i(f)$ or $Q_i(f)$ equal to zero. We apply Lemma 8, with $N = 4$, $x_j = \sqrt{h_j + t}$, $y_j = \sqrt{k_j + t}$, $K = \sqrt{H}$ (by (3.6)), δ the same as in (3.7) and $r = 2$, to see that

$$(3.10) \quad 0 \neq P_i(f), Q_i(f) \ll \delta H^4, \quad \text{for } i = 1, \dots, 4.$$

We let $a = (h_1 + \dots + h_4)/4 = (k_1 + \dots + k_4)/4$, by (1.1). We suppose, that

$$(3.11) \quad |k_4 - a| = \max_i \{ \max |h_i - a|, \max |k_i - a| \}.$$

This is one of 8 similar cases. We may suppose, that

$$(3.12) \quad k_4 \leq a.$$

Otherwise, we count $-f$, replacing (h_1, \dots, k_4) by $(H - 1 - h_1, \dots, H - 1 - k_4)$, so that (1.1), (1.4), (3.10), (3.11) and (3.12) are still all satisfied.

By (3.11) and (3.12) $k_4 \leq h_i$, k_i , for $i = 1, \dots, 4$ and, by (3.10), $h_i \neq k_j$, for $i, j = 1, \dots, 4$, so that

$$(3.13) \quad k_4 < h_i, \quad \text{for } i = 1, \dots, 4.$$

We now dispose of those f for which $F(h_1 - k_4, \dots, h_4 - k_4) = 0$. By Lemma 1

$$(3.14) \quad k_1 = k_2 = k_3.$$

We suppose that $h_4 \leq h_i$, for $i = 1, \dots, 4$. There are 4 such similar cases. Let $y_i = h_i - (h_4 - 1)$, $x_i = k_i - (h_4 - 1)$, for $i = 1, \dots, 4$. By (3.13), $1 \leq y_i \leq h_i - k_4$, for $i = 1, \dots, 4$. Hence, by (3.10), $1 \leq y_1 y_2 y_3 y_4 \leq P_4(f) \ll \delta H^4$ and, as

$y_4 = 1$, we get $1 \leq y_1 y_2 y_3 \ll \delta H^4$. By (3.14) $x_1 = x_2 = x_3$. (1.1) becomes

$$3x_1^2 + x_4^2 = y_1^2 + y_2^2 + y_3^2 + 1^2,$$

$$3x_1 + x_4 = y_1 + y_2 + y_3 + 1.$$

There are $\ll \delta H^4 \log^2 H$ choices for the positive integers y_1, y_2, y_3 . Then there are at most 2 choices for x_1 , as a root of a known quadratic equation. x_4 is then determined. f contains the member $(y_1, y_2, y_3, 1, x_1, \dots, x_4)$ and so (taking account of the 4 similar cases)

(3.15) there are $\ll \delta H^4 \log^2 H$ families, f , for which the conditions of the lemma, (3.10), (3.11), (3.12) and $F(h_1 - k_4, \dots, h_4 - k_4) = 0$ all hold.

We now treat those f for which $F(h_1 - k_4, \dots, h_4 - k_4) \neq 0$. By (3.13), we may suppose that $1 \leq h_4 - k_4 \leq h_3 - k_4 \leq h_2 - k_4 \leq h_1 - k_4$. There are 4! such similar cases. Suppose it were true that $h_2 - k_4 < (h_1 - k_4)/3$. Then

$$\begin{aligned} a - k_4 &= ((h_1 - k_4) + \dots + (h_4 - k_4))/4 \\ &< (h_1 - k_4)(1 + \frac{1}{3} + \frac{1}{3} + \frac{1}{3})/4 = (h_1 - a)/2 + (a - k_4)/2, \end{aligned}$$

so $a - k_4 < h_1 - a$, which contradicts (3.11) with (3.12). Therefore,

$$h_2 - k_4 \geq (h_1 - k_4)/3.$$

By (1.4) and (3.13), $1 \leq h_i - k_4 < H$, for $i = 1, \dots, 4$. Writing $x = h_1 - k_4$, $y = h_2 - k_4$, $v = h_3 - k_4$, $w = h_4 - k_4$, we have $F = F(x, y, v, w) \neq 0$, $1 \leq w \leq v \leq y \leq x < H$ and $y \geq x/3$. From (3.10), $P_4(f) \ll \delta H^4$, so $xyvw \ll \delta H^4$ and $x(x/3)vw \ll \delta H^4$. Putting

$$(3.16) \quad T = T(vw) = \min \{ H, \sqrt{3c\delta H^4/vw} \},$$

where c is the implicit constant in the order of magnitude bound, we have $x \leq T$. Therefore, by (2.2) and the discussion following Lemma 1, the number of these f is

$$(3.17) \quad \ll \sum_{1 \leq v, w \leq T} \sum_{\substack{0 \leq x, y \leq T \\ F > 0 \\ F_1 \equiv 1 \pmod{3}}} \sum'_{\substack{d|F_1 \\ d \leq \sqrt{F_1}}} \left(\frac{d}{3} \right).$$

Let $\mathcal{A} = \{(x, y) \in \mathbb{R}^2 : 0 \leq x, y \leq T, F(x, y, v, w) \geq 3^m d^2\}$. As in Lemma 6, we rewrite the sum over x, y, d as

$$\sum_m \sum_{1 \leq d < T/(\sqrt{3})^m} \left(\frac{d}{3} \right) \sum'_{\substack{(x, y) \in \mathcal{A} \\ F \equiv b \pmod{q}}} 1.$$

The sum over (x, y) is

$$\sum_{\substack{(\theta, \varphi) \pmod{q} \\ F(\theta, \varphi, v, w) \equiv b \pmod{q}}} \sum_{\substack{(x, y) \in \mathcal{A} \\ (x, y) \equiv (\theta, \varphi) \pmod{q}}} w(x, y),$$

where

$$w(x, y) = \begin{cases} 1, & F \geq 3^m d^2, \\ 1/2, & F = 3^m d^2. \end{cases}$$

We may apply Lemma 5, with $n = 2$, $d = 2$ to see that the inner sum here is

$$\frac{1}{q^2} V(\mathcal{A}) + O\left(\frac{T}{q} + 1\right).$$

If $q \leq 3T$, then we sum over (θ, φ) to see that

$$\sum_{\substack{(x, y) \in \mathcal{A} \\ F \equiv b \pmod{q}}} 1 = (V(\mathcal{A}) + O(qT)) D(b \pmod{q}; v, w).$$

If $q > 3T$, then, as $d < t$, there is a unique integer t , with

$$(3.18) \quad 1 \leq t \leq m \quad \text{and} \quad T < q_1 \leq 3T, \quad \text{where } q_1 = 3^t d.$$

$$\begin{aligned} \sum_{\substack{(x, y) \in \mathcal{A} \\ F \equiv b \pmod{q}}} 1 &\leq \sum_{\substack{(x, y) \in \mathcal{A} \\ F \equiv 0 \pmod{q_1}}} 1 = (V(\mathcal{A}) + O(q_1 T)) D(0 \pmod{q_1}; v, w) \quad (\text{as above}) \\ &\ll T^2 D(0 \pmod{q_1}; v, w). \end{aligned}$$

As in Lemma 6, we now have three sums to estimate.
First Sum:

$$S_1 = \sum_m \sum_{1 \leq d \leq T/3^m} \left(\frac{d}{3}\right) V(\mathcal{A}) D(b \pmod{q}; v, w).$$

By the multiplicativity of the (non-negative) densities and Lemma 3,

$$S_1 \ll \sum_m \frac{1}{3^m} \sum_{1 \leq d \leq T/3^m} \left(\frac{d}{3}\right) V(\mathcal{A}) \frac{1}{d} \sum_{r|d} \left(\frac{r}{3}\right) \frac{1}{r} c_r(3vw).$$

Note that, $c_r(3vw) = \sum_{s|(r, |3vw|)} \mu(r/s)s$ and $v, w > 0$, $(r, 3) = 1$ (when $\left(\frac{r}{3}\right) \neq 0$), so $(r, |3vw|) = (r, vw)$. We substitute $r = st$ and $d = re = ste$, to rewrite the sum over d as

$$\sum_{\substack{s|vw \\ (s, 3) = 1}} \frac{1}{s} \sum_{\substack{t, (t, 3) = 1}} \frac{\mu(t)}{t^2} \sum_{1 \leq e \leq T/3^{m+1}} \left(\frac{e}{3}\right) \frac{V(\mathcal{A})}{e}.$$

As in Lemma 6, we see that the sum over e is $\ll T^2$. As $|\mu(t)| \leq 1$, we may complete the sums over m and t , to see that

$$S_1 \ll T^2 \sum_{s|vw} (1/s) = T^2 \sigma(vw)/vw.$$

Second Sum:

$$S_2 = \sum_m \sum_{\substack{1 \leq d \leq T/3^m \\ (d, 3) = 1}} qTD(b \pmod{q}; v, w).$$

We repeat the substitutions made in S_1 , to obtain the bound

$$S_2 \ll T \sum_m \sum_{s|vw} \sum_t \frac{1}{t} \sum_{1 \leq e \leq T/3^{m+1}} 1.$$

The sum over e is $\leq T/3^{m+1}$. As above, we may complete the sums over m and t to see that $S_2 \ll T^2 \sigma(vw)/vw$.

Third Sum:

$$S_3 = \sum_m \sum_{\substack{T/3^m < d \leq T/(\sqrt{3})^m \\ (d, 3) = 1}} T^2 D(0 \pmod{q_1}; v, w).$$

As the densities are non-negative, we may use (3.18) to replace one T by $3^t d$. We then make the substitutions made in S_1 , to obtain the bound

$$S_3 \ll T \sum_m \sum_{s|vw} \sum_t (1/t) \sum_{T/3^{m+1} < e \leq T/(\sqrt{3})^{m+1}} 1.$$

The sum over e is $\leq T/(\sqrt{3})^{m+1}$. We complete the sums over m and t , to see that $S_3 \ll T^2 \sigma(vw)/vw$.

From the bounds for the three sums and (3.16), we see that the right-hand side of (3.17) is

$$\begin{aligned} (3.19) \quad &\ll \sum_{1 \leq v, w \leq T} T^2 \frac{\sigma(vw)}{vw} \ll \sum_{1 \leq v, w \leq H} \frac{\delta H^4 \sigma(v) \sigma(w)}{vw} \\ &\ll \delta H^4 \left\{ \sum_{1 \leq v \leq H} \frac{\sigma(v)}{v^2} \right\}^2 \ll \delta H^4 \log^2 H. \end{aligned}$$

The bounds (3.9), (3.15) and (3.19) complete the proof of the lemma. ■

THEOREM 1. *The number of integer solutions of (1.1), (1.2) and (1.4) is $\ll H^4 + \Delta H^5 \log^3 H$, where H is a positive integer and $\Delta \geq 0$.*

Proof. By Lemma 7,

(3.20) the number of trivial solutions of (1.1) and (1.4) is $A(H) \ll H^4$ and every non-trivial solution of (1.1) is a member of a non-trivial family.

Let f be a non-trivial family containing an integer solution of (1.1) and (1.4), (h_1, \dots, k_4) . The members of f are of the form $m(t) = (h_1 + t, \dots, k_4 + t)$, where $t \in \mathbb{R}$.

(3.21) The set of values of t , for which $m(t)$ is a solution of (1.4), is an interval $[L, U)$, of length $< H$.

Given $a \in \mathbb{R}$, we let

$$C(a; X_1, \dots, X_8) = \prod_{\varepsilon_i = \pm 1} (\varepsilon_1 X_1 + \dots + \varepsilon_8 X_8 - a).$$

This is a polynomial in X_1, \dots, X_8 which is even in each X_i , has degree 2^8 and has the two factors $(X_1 + \dots + X_4 - X_5 - \dots - X_8 \pm a)$. Hence, $C(\Delta H^{3/2}; (h_1 + t)^{3/2}, \dots, (k_4 + t)^{3/2})$ is a polynomial of degree at most 384 in t , with zeros when $M_{3/2}(f, t) = \pm \Delta H^{3/2}$.

(3.22) Therefore, the set of values of $t \geq L$ for which $m(t)$ is a solution of (1.2) is a closed set \mathcal{S} , with at most 385 boundary points.

$m(t)$ is a solution of (1.2) and (1.4) in integers if and only if $t \in \mathbb{Z} \cap [L, U) \cap \mathcal{S}$. By (3.22), $[L, U) \cap \mathcal{S}$ is a union of at most 385 disjoint intervals. Therefore, if $T(f)$ is the maximum number of integers contained in any one of these intervals, then

(3.23) The number of members of f which are integer solutions of (1.2) and (1.4) is $\leq 385T(f)$.

If $0 \leq T(f) \leq 1$, then we use (3.23) and Lemma 6 to see that

(3.24) the total number of solution from such "separated" families is $\ll H^4$.

If $T(f) \geq 2$, then there is an interval $I \subset [L, U) \cap \mathcal{S}$ containing $T(f)$ integers. We may suppose that (h_1, \dots, k_4) was chosen so that $t = 0$ is the least integer in I . Therefore $[0, T(f) - 1] \subset [L, U) \cap \mathcal{S}$. By (3.21) and (3.23),

(3.25) $m(t)$ is solution of (1.2) and (1.4), for $t \in [0, T(f) - 1]$.

Now, $2 \leq T(f) \leq H$, so we may divide up the range for $T(f)$ into the ranges

(3.26) $L \leq T(f) < 2L$, where L is a power of 2 and $2 \leq L \leq H$.

(3.27) There are $\ll \log H$ of these ranges.

Now,

$$\frac{d}{dt}(M_{3/2}(f, t)) = \frac{3}{2} M_{1/2}(f, t),$$

so that, by the First Mean-Value Theorem, there exists $\tau \in [0, T(f) - 1]$ with

$$(M_{3/2}(f, T(f) - 1) - M_{3/2}(f, 0)) / (T(f) - 1) = \frac{3}{2} M_{1/2}(f, \tau).$$

Therefore, by (3.25) and (3.26),

$$|M_{1/2}(f, \tau)| \leq \frac{4}{3} \Delta H^{3/2} / (T(f) - 1) \leq \left(\frac{8H}{3L} \Delta \right) H^{1/2},$$

$$|M_{3/2}(f, \tau)| \leq \Delta H^{3/2} \leq \left(\frac{8H}{3L} \Delta \right) H^{1/2}$$

and

$$0 \leq h_i + \tau, k_i + \tau < H, \quad \text{for } i = 1, \dots, 4.$$

These non-trivial f satisfy the conditions of Lemma 9 with $\delta = (8H/3L)\Delta$. Therefore,

(3.28) there are $\ll (H/L)\Delta H^4 \log^2 H$ such f .

By (3.23),

(3.29) each such f has at most $770L$ members which are integer solutions of (1.2) and (1.4).

By (3.20), (3.27), (3.28) and (3.29), we see that the total number of non-trivial, integer solutions of (1.1), (1.2) and (1.4) from non-"separated" families is $\ll \Delta H^5 \log^3 H$. Combining this with (3.20) and (3.24) completes the proof of the theorem. ■

THEOREM 2. *The number of integer solutions of (1.1), (1.2), (1.4) and (1.5) is $A(H) + O(\Delta H^5 \log^3 H)$, where H is a positive integer, $\Delta \geq 0$ and $0 \leq \Delta_2 \leq \Delta H \log H$.*

Proof. By Lemma 7, the number of trivial solutions is $A(H)$. The proof continues, as in Theorem 1, except that, when $0 \leq T(f) \leq 1$, we can apply Lemma 9 with $\delta = \Delta_2$. ■

Added in proof. In that part of the proof of Theorem 1 which leads up to statement (3.22) I have failed to consider the possibility that the polynomial in t ,

$$C(\Delta H^{3/2}; (h_1 + t)^{3/2}, \dots, (k_4 + t)^{3/2}),$$

has all its coefficients equal to zero. In fact this cannot occur when $\Delta > 0$ (the only case we need consider). This can be seen by using the binomial theorem to investigate the asymptotic behaviour of the factors

$$\varepsilon_1 (h_1 + t)^{3/2} + \dots + \varepsilon_8 (k_4 + t)^{3/2} - \Delta H^{3/2},$$

for large positive values of t .

The distribution of powerful integers of type 4

Let $k \geq 2$ be a fixed integer. A natural number n_k is said to be *powerful of type k* if $n_k = 1$ or if each prime factor of n_k divides it at least to the k th power. This paper is concerned only with the distribution of powerful integers n_4 of type 4. Such a number can be uniquely represented by

$$n_4 = a_0^4 a_1^5 a_2^6 a_3^7,$$

where a_1, a_2, a_3 are square-free numbers and $(a_i, a_j) = 1$ for $1 \leq i < j \leq 3$. We put

$$f_4(n) = \begin{cases} 1 & \text{for } n = n_4, \\ 0 & \text{for } n \neq n_4. \end{cases}$$

Let $N_4(x)$ denote the number of powerful integers of type 4 not exceeding x . Then

$$N_4(x) = \sum_{n_4 \leq x} 1 = \sum_{n \leq x} f_4(n).$$

For the Dirichlet series

$$F_4(s) = \sum_{n_4=1}^{\infty} \frac{1}{n_4^s} = \sum_{n=1}^{\infty} \frac{f_4(n)}{n^s}$$

we obtain

$$(1) \quad F_4(s) = \prod_p \left(1 + \frac{p^{-4s}}{1-p^{-s}} \right) = \frac{\zeta(4s)\zeta(5s)\zeta(6s)\zeta(7s)}{\zeta(10s)} \sum_{n=1}^{\infty} \frac{c_{11}(n)}{n^s},$$

where the Dirichlet series $\sum c_{11}(n)n^{-s}$ is absolutely convergent for $\text{Re}(s) > 1/11$. This shows that an asymptotic representation for $N_4(x)$ may be written in the form

$$(2) \quad N_4(x) = \sum_{v=4}^7 \gamma_{v,4} x^{1/v} + o(x^{1/4}),$$
